## FOREIGN TRADE & CONSULTING

- Finalizing Customs clearance processes of the products; import and export operations
- Creation and / or control of documents regarding to foreign trade transactions (customs declaration, invoice, bill of lading, AWB, CMR, FCR, A.TR Movement Certificate, insurance policy, packing list, etc.)
- Providing advantageous, cost and risk free solutions about processes of Customs regimes, customs warehousing transactions, Customs exemption transactions, free zones issues
- Providing cost saving measures to the companies to decrease tax and cost burdens by following up the economic and political agenda and currency rates closely
- Providing guidance and briefing to the companies regarding to the disputes with Customs authorities, objection and court litigation processes
- Conduct of post-import controls carried out by investigators as per Customs and risk management regulations
- Providing consultancy to the firms and to the sectoral organisations regarding to trade defence policy instruments such as anti-dumping and subsidy measures, safeguard measures, Anti Circumvention and Monitoring measures, and free trade agreements
- Giving guidance and briefing to the companies on tax regulations about foreign trade transactions
- Receiving advance rulings, information and/or opinions from the related government authorities about tax subjects/ issues
- Evaluation of tax assessment or tax penalty decisions such as import Customs duties, special consumption tax (ÖTV), value added tax (KDV-VAT), resource utilisation support fund (KKDF), and other equivalent effect taxes.
- Conduct of objection, reconciliation, or litigation processes about tax decisions
- Estimation, calculation and optimization of the taxes and landed costs of any products that are planned to be imported

## PRODUCT IMPORT & PLACING ON MARKET

- Conduct of Product Safety and Quality Control processes (ÜGD) under Risk Based Trade Control System (TAREKS) and getting import/export permission certificates (product safety and control approval document) from Ministry of Trade, TSE, and any other government authorities.
- Doing Customs clearance of the products which are to enter into or exit from Turkish customs zone; import-export operations
- Doing IMEI registration of devices at BTK after import of goods
- Class 2 Notification Form Applications and getting Class 2 Compliance certificate from Spectrum Management Department
- TAC Registration (Type Approval Code ) at CEIR (MCKS) System
- Receiving Environmental Compliance Certificate (Çevre Uyum İzni) for import of batteries and accumulators
- Receiving banderols from TRT Institution for imported goods

## **SHIPPING AND WAREHOUSE MANAGEMENT**

- Following and finalizing all kinds of international trade transactions including import, export, transit trade, inward and outward processing regime, temporary imports
- Organization of international transport and insurance transactions as per incoterms rules
- Providing warehousing services for the products imported to Turkish Customs zone
- Delivering goods to the company's warehouse in Turkey after clearing the goods from customs.

## **CUSTOMS TARIFF**

- Determining the exact HS code / Customs commodity code (GTİP) of the items that are planned to be imported
- To receive Tariff Information or Binding Tariff Information (BTB - BTI) from the Customs authorities regarding to new technology and complicated devices
- To inform companies about BTIs and tariff classification decisions given on the related products by Turkish Customs authorities, European Commission Taxation and Customs Union
- To inform companies about tariff decisions and agreements held by World Trade Organization and World Customs Organization
